## RESEARCH HIGHLIGHTS

### ONGOING PROJECTS

#### Evaluation of Information and Communication Technology Use in Public High Schools in the Turkish Republic of Northern Cyprus

Project Managers: Assoc.Prof.Dr. Behbood Mohammadzadeh and Asst. Prof. Dr. Tolgay Karanfiller

Nowadays, the acceptance of English as a global language has further increased the importance of English language education supported by information and communication technologies. At this point, there is a need to conduct a research on how teachers create a supportive environment in the classroom to teach English more effectively and to bring education to a higher level by using information and communication technology supported methods. The study was conducted with the aim of guiding English teachers working in state high schools in the TRNC to use communication technologies, to introduce the methods used in other countries and contribute to the preparation of programs for teaching English in the Turkish Republic of Northern Cyprus (TRNC). Researchers will use both qualitative and quantitative methods during the research. To figure out an answer for the first sub-question, a questionnaire will be conducted for teachers in order to determine the levels and perceptions of their self-efficacy for the use of information and communication technology while teaching English at state high schools in the TRNC. In addition, qualitative interviews and focus group studies will be conducted. According to the findings, some application methods will be used to find out results for the secondary sub-question which is 'What kind of in-service training can be done for the state high school English teachers to increase the use of information and communication technologies to support English language teaching methods?' Researchers Mohammadzadeh and Karanfiller said after finding the applications and implementations in different countries in the world, they aim to transfer the information to teachers in the TRNC and guide other teachers and researcher in this area. This study aims to improve the quality of English education and to enable teachers and students to use information and communication technologies more effectively.

#### Biodiesel Production Efficiency in Treatment of Solid Waste Landfill Leachate by Algal-Bacterial Cocultivation

Project Manager: Assoc. Prof. Dr. Emrah Ahmet Erkurt

This work initiated a scientific study on the simultaneous treatment of biodiesel especially designed FBR for the development of algae-bacteria symbiotic leachate of solid waste landfill area which is not possible to be treated in conventional wastewater treatment systems. In this study, optimization of ambient conditions and hydraulic and organic loading in continuous type treatment by using microalga-bacteria co-cultivation of Güngör solid landfill area leaching water is investigated by using pilot scale cascade type 250 L capacity equipped with special led lamps which are not included in the literature. Assoc. Prof. Dr. Erkurt said the highest purification efficiency of the microalgae biomass to be obtained after the cultivation conditions will be achieved lipid extraction and biodiesel production will be made as a result of the optimization studies. Erkurt said "According to the zero waste concept, the biodiesel production reaction by-product glycerol will be fed back into the photo bioreactor." Assoc. Prof. Dr. Erkurt stated that after the oil

extraction process, the residual cell residues containing the pulp will be analysed according to the eligibility criteria of animal nutrient additives. Cost analysis will be done as the last step in the study, he said. He pointed out that the treatment of the leachate of solid waste landfills in the hazardous wastes category is not carried out in Northern Cyprus. This situation increases the danger to nature and human health every day. Prof. Dr. Erkurt indicated that implementing such a process, will eliminate a hazardous waste problem and biodiesel production may occur. He said, "Therefore, the negative impact on nature and human health will be eliminated." Erkurt stated that the emission values of the exhaust gases produced by the use of biodiesel are much lower than oilbased diesel, therefore, air quality will improve. Erkurt pointed out that the dependence on oil in the country could be reduced with the implementation of the mentioned process. "In this way, new job opportunities will emerge", he said.

#### Anticancer and Antibacterial Properties of Some Endemic Species From Labiate Family Growing in Northern Cyprus

Project Manager: Assist. Prof. Dr. Ender Volkan

Asst. Prof. Dr. Ender Volkan Çınar, from the Faculty of Pharmacy, Cyprus International University (CIU), started a project on the anticancer and antibacterial properties of some endemic species from the Labiate family that grows in Northern Cyprus. Asst. Prof. Dr. Çınar said that they conduct a scientific study including a biological activity about the effects of some endemic species belonging to the Labiate family from Northern Cyprus with anticancer and antimicrobial extracts to be obtained from the essential oils. The project aims to fill the existing scientific gap related to the flora of Northern Cyprus by exploring the medical properties of many endemic species in Northern Cyprus, it will also help raise awareness about the vegetation in the island. Labiate family contains a number of important medicinal plants and these plants grow in areas where there is the density of maquis and garig. It was pointed out that these flowering plants, which are particularly rich in essential oil contents, have been used among the people for centuries for both spices and various diseases and their scientific effects have been revealed by scientific research. Asst. Prof. Dr. Ender Volkan Çınar stated that although there are many species belong to this family in Northern Cyprus, there are very few studies on them.

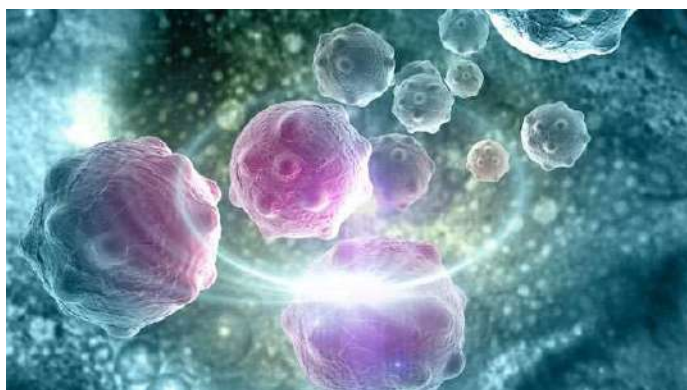
The project will concentrate on the anti-microbial and anti-cancer effects of these species. The solution-oriented effects of the molecules to be obtained from the plants will be studied on cancer and the anti-microbial resistance which causes more and more problems. The main purpose of the project is to contribute to the development of integrative treatment types in the treatment of infectious diseases, general infectious diseases and cancer, which also has an anti-microbial resistance profile. The protection of these species will be ensured with the increase of social awareness and interest about the flora of the island.

#### A Project on the Status of Elderly in TRNC From the Faculty of Health Sciences

Project Manager: Prof. Dr. Feray Gökdoğan

Prof. Dr. Feray Gökdoğan, Dean of the Faculty of Health Sciences, Cyprus International University (CIU), stated that a project on "Determining the Health and Socio-Cultural Situations of the Elderly

Living in the TRNC" will contribute to the establishment of the database for the determination of problems and their solutions to be provided for the elderly welfare in the TRNC. One of the most important demographic facts in the 21st century is the aging of the population. In the context of the increasing tendency of the elderly population, the TRNC population is in the upper limit of the "elderly" group in 2006 but it is assumed that it can be in the "very old" group when current data are obtained. Starting from this point of view, the two-year project on "Determining the Health and Socio-Cultural Situations of the Elderly Living in the TRNC" was presented to be supported by CIU TRNC Research Projects. The project, which was conducted under the leadership of Prof. Dr. Feray GÖKDÖĞAN, Dean of Faculty of Health Sciences, 20 students from the Faculty of Nutrition and Dietetics, Physiotherapy and Rehabilitation, Nursing and Social Work were interviewers and lecturers were assigned as auditors. A total of 1904 elderly people living in Güzelyurt, Lefke, Kyrenia, İskele, Gazi Magosa and Nicosia from west to east in North Cyprus were visited in their homes in April-May 2018 and the data of the research was collected by face-to-face interviews. With the sample determined by proportion from the population in Northern Cyprus, there is no such generalized comprehensive study related to the elderly alike. Therefore, our project will contribute as an important data source to reveal how the elderly in the TRNC experience old age. Prof. Dr. Gökdoğan stated, "Aging occurs in the human body with various changes and as a result of this, some health problems emerge. Due to the deterioration of economic conditions in the old age, social and mental problems can appear." Gökdoğan said that due to the gradual aging of the population, it is important to plan and organize services related to old age. She stated that, "Not only within the scope of financial assistance but within the scope of the society, should policies developed for the elderly be put forward in a way that allows the evaluation of all aspects of the issue." It is thought that this research will shed light on the units concerned with the relevant public institutions in Northern Cyprus regarding the services to be provided for elderly welfare, identification of problems and ways of solution both at the local and national scale.



### Development of Intelligent Lipid-Based Nanotherapeutics to Be Used in Cancer Treatment

Project Manager: Assoc. Prof. Dr. Doğa Kavaz

Assoc. Prof. Dr. Doğa Kavaz, Lecturer of the Faculty of Engineering, Cyprus International University (CIU), initiated a scientific study to develop multi-functional solid lipid delivery systems using nanotechnological approaches, one of the next generation treatment strategies for the treatment of cancer diseases. Assoc. Prof. Dr. Kavaz said that cancer comes at the top of the list of illnesses that affect the quality of life all over the world that ends with death. She stated that diagnosing and treatment of these

diseases have not had an ideal solution yet. Assoc. Prof. Dr. Kavaz talked about the research related to new generation cancer diagnosis and treatment. "Nanocarrier systems, which are very interesting in cancer treatment due to their unique accumulation behavior in tumor regions, increase the efficacy of the drugs used, improve the therapeutic index, decrease the toxicity of the drug, ensure the stability of the drug in the long term and increase the solubility and stability of the drug," she said. Kavaz stated that for these reasons, lipid-based receptor-mediated nano carriers will be prepared and characterized for the use in cancer treatment as part of the project.

Kavaz pointed out that the surface properties of these particles will be examined after the preparation of nanoparticles. She announced that the nanoparticles will be activated with the model ligand to target "active" cancer cells. Assoc. Prof. Dr. Kavaz said that anti-cancer drug nanoparticles will be loaded in the continuation of the study. Then drug profiles will be obtained and then biocompatibility tests will be conducted. Kavaz reported that at the last stage of the study, the tumor selectivity will be targeted by targeting nanoparticles to cancerous and healthy cells. Selected anti-cancer drugs will be loaded into the carrier and they will investigate the interaction with cancer cells. Assoc. Prof. Dr. Kavaz stated that the aim of the study was to make significant contributions to the studies in the field of receptor-based cancer treatment both scientifically and clinically. Kavaz added that the strategy for breast cancer treatment, which will be considered as a model application within the scope of this project, can be easily spread to other types of cancer. "In addition, the nanoparticulate carrier system that will be developed within the scope of the project will be easily modified and used in early cancer diagnosis in different types of cancer," she said. Kavaz said with the results to be obtained as part of the project, cancer, which is threatening the health of people all over the world, will be possible to treat healthy cells and tissues without damage.

### Osman Türkay Documentary, A Universal Lyric Monument From Cyprus

Project Manager: Prof. Dr. Metin Karadağ

A documentary is being prepared about the life, works, and thoughts of the world-famous Turkish Cypriot poet Osman Türkay. The documentary would be produced primarily to be shown in Northern Cyprus and later in Turkey and the Turkish world. Türkay's life would be produced as a scripted documentary based on his life, poems and thoughts.

Prof. Karadağ recalled that Osman Türkay was born in 1927 in the village of Kazafana (Ozanköy) in Kyrenia. He said that he gained a universal reputation for his poems which he usually wrote in the English language. He was one of the first Turkish poets to be nominated for the Nobel Prize in literature. The documentary is going to be about the life of the poet, the places he lived, his relatives, venues dealt with in his poems, monuments, historical places and mythological places. In the first steps of making the documentary, scenario studies will be created and then preliminary studies will be done with student groups. After field observations and filming, programs will be organized and the raw materials will be completed, and then montage and sound recordings will be done. Finally, efforts will be made to show the documentary on local, national and even international channels.

## Performance Analysis of Solar Collectors Using Nano-Liquid

Project Manager: Prof. Dr. Serkan Abbasoğlu

The effects of different nanoparticle-containing liquids (Al<sub>2</sub>O<sub>3</sub> and ZnO) is studied on efficiency in local collectors produced from different materials (Copper and Galvanized). The research was part of his study on 'Performance Analysis of Solar Collectors Using Nano-Liquid'. The island of Cyprus is the leader of Europe considering the residential use of thermal solar water heating systems. Similarly, it has the highest solar radiation values in Europe in terms of geography and meteorology. However, it was stated that these systems cannot provide the necessary benefits because of the low efficiency of local solar collectors.

Therefore, two systems were installed on the CIU campus and data analysis was carried out for approximately six months. The water used in our island's heating systems is accepted as a reference. We conducted the project to compare two different nanoparticle-containing liquids with water-operated systems to find more efficient alternatives". In two different systems, heating systems with nanoparticle fluids containing variable proportions of Al<sub>2</sub>O<sub>3</sub> and ZnO were operated and efficiency calculation was made according to ASHRAE 93: 2003 standard. In addition, under the influence of ethyl glycol, the efficiency of these nanoparticles was examined. According to the results, the influence of ethyl glycol Al<sub>2</sub>O<sub>3</sub> has reached to the highest yield and the increase in this yield increased by 15.3% compared to water. Prof. Dr. Abbasoğlu indicated that the results of the study were published in an indexed journal. Thus, Erdoğan Arıkan, the doctoral student, who carried out the study cooperatively, earned the title of Doctor and many international publications have been done by experts by the Sustainable Energy Research Center since 2011. He also pointed out that by implementing many of these studies, they, within Cyprus International University, created living examples for all solar experts and interested people.

## Antimicrobial Substances That Can Be Used Instead of Paraben

Project Managers: Prof. Dr. Tanver Doğanay and Assist. Prof. Dr. Tanem Garanti

Prof. Dr. Tanver Doğanay and Asst. Prof. Dr. Tanem Garanti from the Faculty of Pharmacy, started a study to identify a natural organic substance that can be used in place of parabens, having an antimicrobial effect and will potentially be healing wounds and preventing degradation of the cosmetic products in extreme conditions. Paraben and paraben derivatives are commonly used in cosmetics to protect against harmful microorganisms such as bacteria, molds, and fungi and added that "paraben and its derivatives are used not only in cosmetics but also in food and pharmaceuticals for the same purpose". It was also stated that although the use of parabens is widespread and effective, studies on animals in recent years, showed that these chemicals increase the level of genes that can lead to cancer in the human body and "therefore, it is mentioned that paraben and its derivatives increase the risk of cancer," said Prof. Dr. Doğanay. It was also pointed out that the American Food and Drug Administration (FDA) has been examining parabens for scientific investigation yet, there is still no restriction on their use. From this point of view, it is important to note that an alternative combination is important for paraben and its derivatives. The primary objective of the project we are conducting is to identify a natural organic substance that can be used instead of parabens, effecting antimicrobials and potentially healing wounds and preventing degradation of the cosmetic product in extreme

conditions, for instance, at high temperatures. These new substances or combinations of substances will be proposed to be used in the design of new cosmetic products and the anti-microbial effects of the identified substances will be examined under laboratory conditions and the structures with high anti-microbial effects will be studied in detail and new drug formulations will be designed to be used for therapeutic purposes. It is foreseen that the newly designed drugs could be used as an alternative to antibiotic treatment.



## Determining In-service Training Needs of Human Resources in TRNC Accommodation Establishments

Project Manager: Assoc. Prof. Dr. Hale Özdoğaç Özgüt

Assoc. Prof. Dr. Hale Özdoğaç Özgüt, a faculty member from the School of Tourism and Hotel Management of Cyprus International University (CIU) started a project on "Determining In-Service Training Needs of Human Resources in TRNC Hospitality Enterprises." The researchers aim to find out why human resources in hospitality businesses need in-service training and to investigate the dimensions of these requirements and what kind of in-service training they would like to have. The study involves all accommodation establishments in the TRNC and attempting to determine which training issues are of priority for human resources within the framework of in-service training. It was also highlighted that the development of the skills and qualifications of the staff working at all levels of accommodation establishments in TRNC is important in terms of increasing the company's performance: "According to the view accepted in general terms in the world and in the TRNC; the quality and skills of the human resources consisting of the owner, line managers and other staff at all levels directly affect the performance of the company". This research project will provide an opportunity for human resources in accommodation businesses to keep up with innovations, gain a perspective of professional development and raise quality standards. The education deficit has always been mentioned by the tourism sector stakeholders said Assoc. Prof. Dr. Özgüt and added that the research in question would also enable us to determine where the deficits are. After defining the critical needs, the areas where resources should be directed and become priority will be identified.

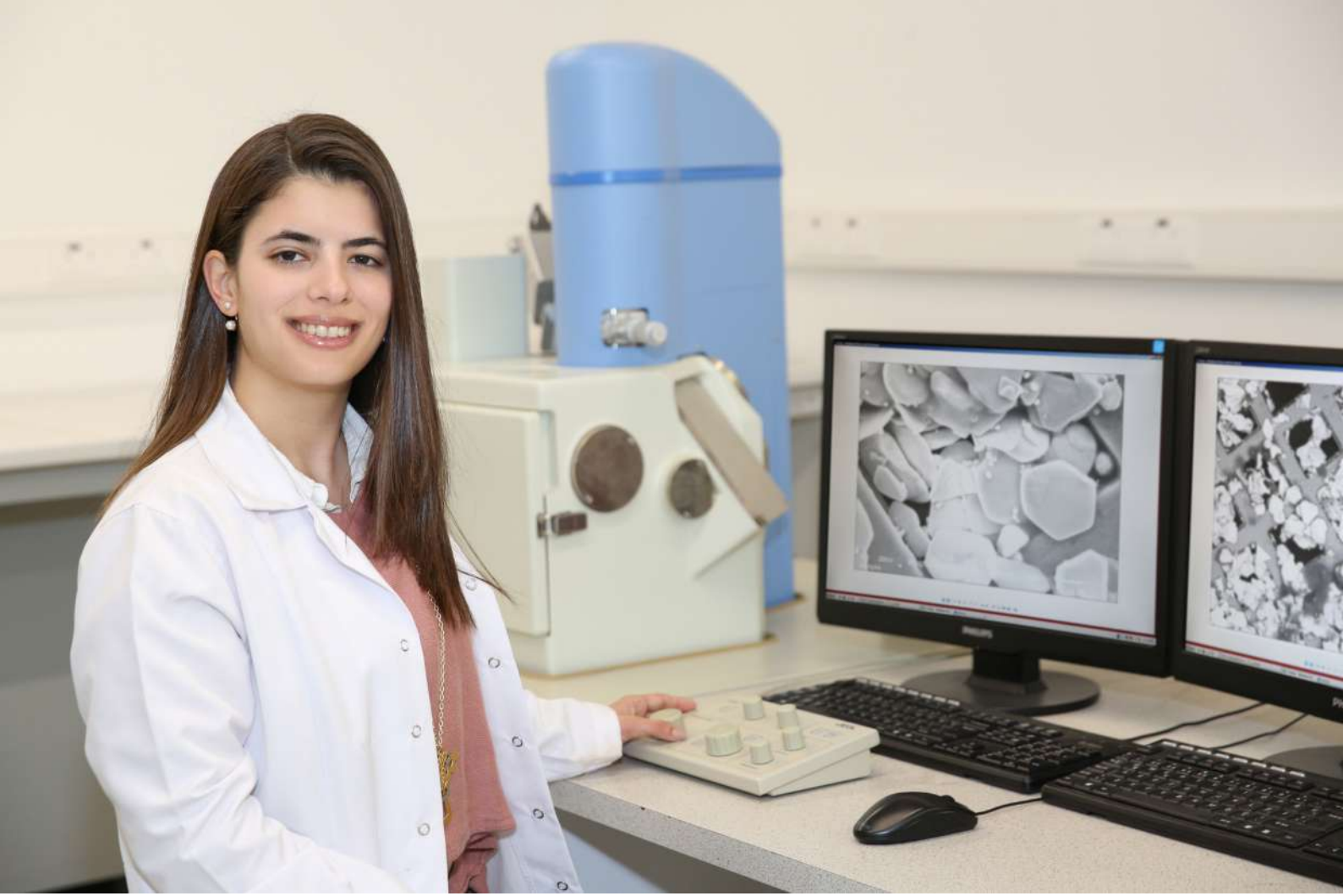
